

## ORDINANCE 10062020-01

**AN ORDINANCE SETTING ADOPTING A MASTER FEE SCHEDULE FOR FEES SET FOR RENTALS, LICENSES, PERMITS, SERVICES, SURCHARGES, AND CERTIFICATES FOR THE CITY OF POTEET; PROVIDING FOR SEVERABILITY, REPEALER, PUBLICATION AND SETTING AN EFFECTIVE DATE**

**WHEREAS**, The City Council desires to ensure that City fees are properly and regularly updated to reflect current costs and conditions; and

**WHEREAS**, The City Council has adopted ordinances setting fees and charges ; and

**WHEREAS**, The City of Poteet reserves the right to amend the Master Fee Schedule at any time when new or current ordinances regarding fees and charges have been approved, amended, or scheduled to take effect.

**NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POTEET, TEXAS:**

**SECTION 1.** That the findings set out in the preamble to this ordinance are hereby in all things and found to be true and shall be incorporated herein for all intents and purposes.

**SECTION 2.** That, in accordance with Section 132.002 of the Texas Local Government Code and subject to such rules and procedures the City Administrator or the City Administrator's designee may prescribe, each City of Poteet employee or other official who collects fees, fines, court costs, or other charges on behalf of the City of Poteet is hereby authorized to accept payment by credit card of such fees, fines, court costs, or other charges.

**SECTION 3.** That the meeting at which this ordinance was passed was conducted in strict compliance with the Texas Open Meetings Act (Texas Government Code Chapter 551).

**SECTION 4. Repealer.** That all other prior ordinances or portions of ordinances of the City of Poteet in conflict with the terms and provisions of this ordinance are hereby repealed to the extent of such conflict only.

**SECTION 5. Severability Clause** That the repeal of any ordinance or portion of an ordinance by this ordinance shall not affect the validity of any pending enforcement action or fees outstanding and due and payable for services rendered on or before the effective date of this ordinance.

**SECTION 6. Savings Clause.** That if any section, paragraph, subdivision, clause, phrase or provision of this ordinance is hereafter determined to be invalid or violative of the laws of State of Texas or the Constitution of the United States by a court of appropriate jurisdiction, such findings of invalidity shall affect the continued enforcement only of the provisions so determined to be invalid, being the intent of the City Council of the City of Poteet that all other terms and provisions of this ordinance not affected thereby shall remain in full force and effect.

**SECTION 7.** That Exhibit "A" is adopted as the Master Fee schedule for the City of Poteet.


